विषय:- भारत सरकार द्वारा Retrofitting एवं Priority Areas की योजनाओं को पूर्ण करने की समय-सीमा विस्तारित करने के संबंध में।



उपरोक्त विषयक प्रासंगिक पत्र के संदर्भ में सूचित करना है कि पूर्व में भारत सरकार द्वारा दिये गए निर्देश के आलोक में NWQSM एवं Retrofitting/Augmentation की योजनाओं को 31 मार्च 2021 तक पूर्ण किया जाना था। वर्तमान में भारत सरकार द्वारा इन योजनाओं को पूर्ण करने की समय सीमा में निम्न रूप से Relaxation दिया गया है-

- i) जलापूर्ति योजनाओं Retrofitting/Augmentation कर FHTC देने का कार्य 31 मार्च 2022 तक पूर्ण कर लिया जाए।
 - ii) Priority Areas जैसे आकांक्षी (Asprational) जिलों, Water Quality से सम्बंधित क्षेत्रों के आच्छादन को प्राथमिकता देकर 31 मार्च 2021 तक पूर्ण कर लिया जाए।
 - iii) नई MVS योजनाओं का कार्यादेश 31 दिसम्बर, 2021 तक समय वद्ध तरीके से निर्गत की जाए।
2. NWQSM अन्तर्गत स्वीकृत/निर्माणाधीन योजनाओं को 31 मार्च 2022 तक पूर्ण किया जाना है

अतः उक्त के आलोक में निदेश दिया जाता है कि अपने प्रमंडल के अधीन योजनाओं के Retrofitting/Augmentation कर FHTC देने से संबंधित कार्यों को स-समय पूरा करने हेतु शीघ्र कार्रवाई किया जाए। इस संदर्भ में सम्बंधित कार्यपालक अभियंता, कि यह जिम्मेवारी होगी कि पूर्व से निर्मित/निर्माणाधीन एवं प्रस्तावित योजनाओं में किसी प्रकार दोहरीकरण (Duplicacy) नहीं हो अन्यथा वे जिम्मेवार होंगे।



Subject: Extension of time period for completion of retrofitting/ augmentation of existing PWS schemes and coverage of all rural households in Aspirational & JE-AES affected districts and approval of MVSS under Jal Jeevan Mission - reg

Madam/ Sir,

I am directed to refer to the provisions made in the Operational Guidelines for expeditious implementation of Jal Jeevan Mission to make provision of tap water supply to every rural household of the country by 2024. National Jal Jeevan Mission is regularly impressing upon the States/ UTs to adopt following strategy/ planning approach as mandated in the Operational Guidelines for the implementation of JJM to ensure assured water supply to every rural home:

- i.) In villages with existing piped water supply system, all remaining households to be provided with water supply by **retrofitting/ augmenting**, if needed, so that 'no one is left out';
 - ii.) In villages where ground/ surface water of good quality in sufficient quantity is available, **single village systems (SVS)** to be planned and executed, which is the **most preferred option**;
 - iii.) Villages with adequate groundwater but having **quality issues**, water to be treated before supply to every household;
 - iv.) In **water-stressed areas**, bulk water transfer, treatment plants and distribution systems to be planned and executed;
 - v.) In isolated tribal hamlets/ hilly/ forested areas, **stand-alone solar-based and/ or gravity-based water supply systems** to be given priority.
2. As per the Operational Guidelines of JJM, all types of retrofitting/ augmentation works in the villages having piped water supply; 27,544 identified Arsenic/ Fluoride affected habitations under NWQSM and; all the 61 (then 60) JE-AES affected districts, should have been covered i.e. all the households in such villages/ habitations should have been provided with tap water connections by 31st March, 2021. Further, approval (including the approval by SLSSC and Administrative approval) for all the MVSS should have been taken before 31st March, 2021. However, the deadline of 31st

March, 2021 for completing all retrofitting/ augmentation works, NWQSM and covering of JE-AES affected districts and approval of MVSs have not been met with by States/ UTs.

A { 3. This department had earlier received requests from the states to extend the time lines for completing on-going/ approved projects under NWQSM. Considering the importance of making provision of safe drinking water in water quality-affected habitations, this department after due deliberations, has extended the timeline for implementation of NWQSM by one year i.e. up to 31.03.2022, with a condition that if any State requires additional fund, it can use JJM fund and unspent fund available on completion of projects will be adjusted against release under JJM.

4. This Department has now received several requests from States for extension of deadline for retrofitting/ augmentation, coverage of priority areas, etc. as per details mentioned in para 2 above. The matter has been examined and in view of the difficulties faced by States/ UTs due to Covid pandemic and resultant disruptions that affected implementation of the works in many parts of the country, the following relaxations have been made as a special case with strict compliance to this effect for:

- i.) all retrofitting/ augmentation of water supply scheme to provide FHTCs and to make them JJM compliant to be completed latest by 31st March, 2022;
 - ii.) coverage of priority areas i.e. Aspirational & JE-AES affected districts to be given top-most priority and to be completed by 31st March, 2022; and
 - iii.) for new multi village schemes, the deadline for awarding contract beyond 31st March, 2021 is extended up to 31st December, 2021.

5. In view of this, States/ UTs to adhere to the above modified timeline to accomplish the goal in a time-bound manner.
