Subject: Request for continuation of Salary drawal of DAOs/DAs using Temporary GPF/CPF Number – reg

Sir,

With reference to the subject mentioned above, I am directed to state that, as the salary bills of officials of Divisional Accountant cadre were not being processed due to red flagging of their Temporary GPF/CPF nos. with which their salary had been mapped, it had been requested vide this office letter no. WM-I/Association/2026-27/30 dated 27/04/2026, to permit the continued use of their existing temporary GPF/CPF numbers, so that there would be no difficulty in drawal of their salary bills and other admissible entitlements.

Although the problem has been resolved in most Treasuries, it has been brought to knowledge that, some issues are still persisting in certain Treasuries and at certain DDO levels, due to which the salary of the officials of DA Cadre is pending for payment since March 2026.

As the officials of DA cadre are Central Government employees under the cadre control of the Pr. Accountant General, and their salary is being processed by issuing a Temporary GPF/CPF no, it is requested that directions may be issued to all Treasury Officers and DDOs of PWD Divisions, that the drawal of salary bills and other admissible entitlements of the officials of DA cadre, may be continued to be made through their existing temporary GPF/CPF numbers. A detailed list of 252 concerned DAO/DAs with Temporary GPF/CPF numbers (from which salary was being processed in Kuber) is enclosed herewith for further needful.
